All Food vendors and individual Chili entrees will be provided with one space with electricity for a tent no larger than $10' \times 10'$. I will be required to provide my own outdoor electrical cord no shorter than 25 feet. Each participate is required to have a canopy/tent and is responsible for their own tent, chairs, tables, weights, etc. We will be following COVID guidelines for social distancing. Each participant will follow Day of Instructions on page 3 of this registration.

As an individual Chili entree: I agree that the entry fee in the amount of \$25.00 is payable upon receipt of registration. I agree to provide a minimum of 2 quarts of Chili for sampling by the judging panel. I agree to allow the panel of restaurant professionals to taste and judge my entry. I attest that my entry has been prepared under sanitary conditions and has been cooked to proper temperatures. I agree to allow no more than two people at any one time in the space provided to me for preparation.

As a product vendor other than food: I/We agree that the entry fee in the amount of \$50.00 for the event is payable upon receipt of registration. I/We understand that all sales taxes are the responsibility of myself or our company.

As a Food Truck: I/We agree that the entry fee in the amount of \$150.00 for the event is payable upon receipt of registration. I/We will not sell any water, soda, or alcoholic beverages. I/We understand that all sales taxes are the responsibility of myself or our company. Electricity will be provided. No propane use will be allowed.

As a restaurant participating in the event: I/We agree that the entry fee in the amount of \$100.00 for the event is payable upon receipt of registration. I/We agree to collect tickets as payment for chili from attendees. I/We agree to provide a minimum of five (5) gallons of chili for sale. I/We will maintain the chili at proper temperature throughout the event. I/We will be provided with electric power for that purpose. I/We will offer nothing other than chili to the attendees. I/We will collect 2 ticket for a three (3) ounce sample size and 4 tickets for a six (6) ounce portion of chili. The participating restaurants will be judged by the number of tickets sold. Payment in the amount of fifty percent (50%) of the monies received for the ticket sales that are collected by myself or my employee(s) will be paid at the end of the event to myself or my company. Ticket value is \$1.00 (one dollars) each. I/We understand that all sales taxes are the responsibility of myself or our company.

Vendors and Individual Entries may arrive as early as 11:00am and no later than 12:00pm. All set-up vehicles must be removed from event area by 12:30pm. You may begin to tear down no earlier than 6:00pm and must be finished by 7:00pm.

Food Trucks and Restaurants may arrive as early as 10:30am and no later than 11:30pm. You must be ready for fire inspection by 12:00pm. All set-up vehicles must be removed from event area before inspection. You may begin to tear down no earlier than 6:00pm and must be finished by 7:00pm.

Monster Truck and Show Vehicles will be placed on a first come basis. Monster Trucks and Show Vehicles may arrive as early as 11:30pm and not later than 12:30pm. No Vehicles will leave the event before 6:00pm and must remain in place until given the signal all is clear and it is safe to leave.
